**Dear Parents and Guardians,**

It is time to start thinking about the summer holidays! The LIS Hort team will be offering the Summer Holiday Hort programme for your child from 08:00 to 17:00 each day. To enrol your child, please return the enclosed registration form.

After registration is completed, Hort colleagues will create the programme. You will receive detailed programme information one week prior to the start of the holidays.

**An activity fee per child of 70 EUR per week per child is required for students in grades 1-5.** This fee covers the costs of activities including materials, transportation and lunches. You will be asked to provide your child with snacks and drinks. For single-parent families (meaning only one parent in household regardless of marital status or relation to child) the price is 50 EUR per week, per child.

Please do not order any lunch at "Gourmet Kids", we will order the lunch.

Please book per week. Holiday Hort bookings are not available for individual days. You can choose a payment option in the enclosed registration form.

### **Enrolment:**

- **How:** please fill out and return the below form either per email to the Hort Leader Team (hort-office@lis.school) or in paper form at the Hort sign-out desk.
- **When:** please return this form at the latest by **Wednesday, 23 May 2018**. Requests received after this deadline must be made directly to the Hort Leader, and will only be accepted on a case-to-case basis depending on space availability. If you are able to obtain a space after the deadline, there will be an additional surcharge of 35 EUR. No late requests will be considered after Monday, 18 June 2018.

### **Cancellation and Reimbursements:**

- **How:** Should you need to cancel your reservation after registration has already taken place, please do so as soon as possible per email to the Hort Leadership Team.
- **When:** The last date for cancelling your Holiday Hort placement is **Monday, 18 June 2018**. Cancellations after this date will not be reimbursed due to costs incurred that we cannot recover.
